1. About DiscoverLondon

Greenspace Information for Greater London CIC (GiGL) is the capital's Local Environmental Records Centre – we mobilise, curate and share data that underpin our knowledge of London's natural environment.

DiscoverLondon (DL) is GiGL's online public data portal where you can investigate dynamic maps of our green city. It's been designed to help the general public find and explore parks and publicly accessible wildlife sites, to showcase featured London projects and to support recorders with vice county and base mapping.

2. How to navigate

Home page








The home page allows you to navigate to any of the map pages within DL. Click on the map icons to start exploring.

Map pages

There are a number of map pages in the DL portal that allow you to explore the nature in the capital. For a full description of each map, please go to [3. Layers](#) within this guide.

The information below will help you navigate the DL portal.

	<p>Type in the search bar located in the top right of the map (or top left for Spaces to Visit and Wildlife Sites) to search for addresses or places within London.</p> <p>For Spaces to Visit and Wildlife Sites, you can also search for names of sites. To refine your search, you can click on the drop down arrow on these map pages to display the search options.</p>
 <p>Menu</p>	<p>Click on this icon in the top right of any of the map pages to open the menu. You can navigate to any page on the portal by click on the titles, including the home page. You can click on the Menu icon again to close it</p>
 <p>Legend</p>	<p>Click on this icon in the top right of any of the map pages to open the Legend. This will tell you what information is on the map and what the colours and icons represent. Click on the Legend icon again to close it.</p>
 <p>Information windows</p> <p><i>Rivers and Waterbodies, Wildlife Crime, London's Landscape and Recording Support map pages</i></p>	<p>When opening the map a window at the bottom of the page (on desktop) will automatically be expanded. This tells you a little bit about what you're seeing on the map and where to find more information. To close or open this window, click on the blue arrow.</p>
<p>Site lists</p> <p><i>Spaces to visit and Wildlife Sites pages only</i></p> 	<p>When opening the map a window to the left of the page (on desktop) will automatically be expanded. This tells you a little bit about what you're seeing on the map and where to find more information. It also includes a list of all sites in London.</p> <p>Click on the 'Zoom' button to zoom to the selected site on the map. Click on the 'Details' button to follow a link to more information on the site, hosted on the GiGL website.</p> <p>Click on the magnifying glass in the top left to open the search bar. When this is open, you can search the list by the site name, or type in a borough to see all sites within that</p>

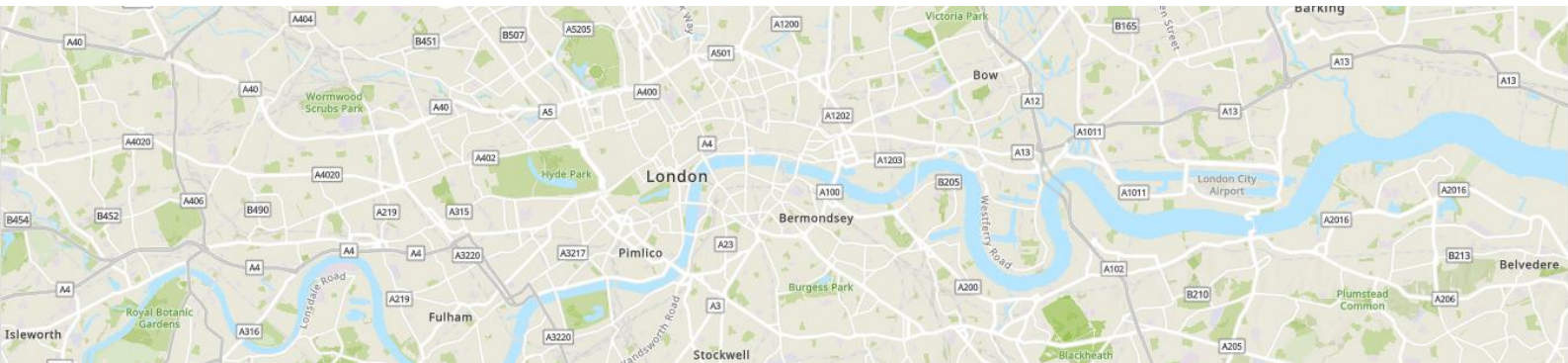
borough. Click on the black arrow pointing left to close the search bar. To close or open the window, click on the blue arrow.

Base map: Esri's World Topographic Map

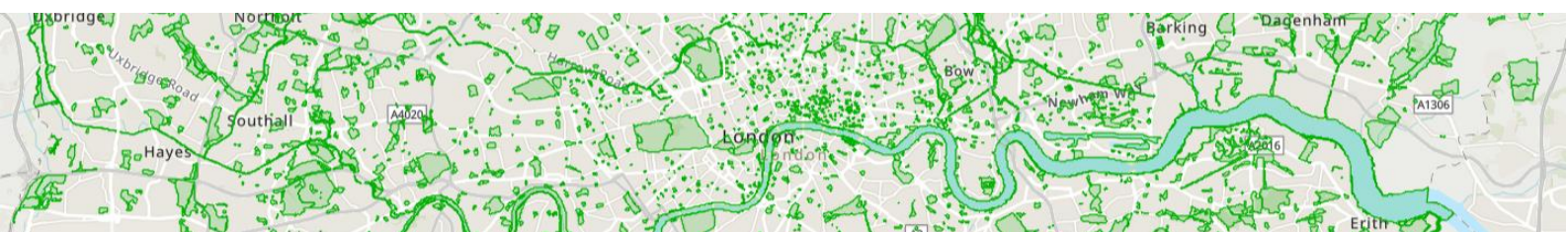


Description: This vector tile layer provides a detailed basemap for the world, symbolized with a classic Esri topographic map style. This layer includes highways, major roads, minor roads, railways, water features, cities, parks, landmarks, building footprints, and administrative boundaries, designed for use with shaded relief for added context.

Spaces to Visit



Description and sources: Spaces to Visit shows publically accessible open space sites in Greater London. Click on any site to open a pop-up with more information, including a link to the full site description hosted on the GiGL website.

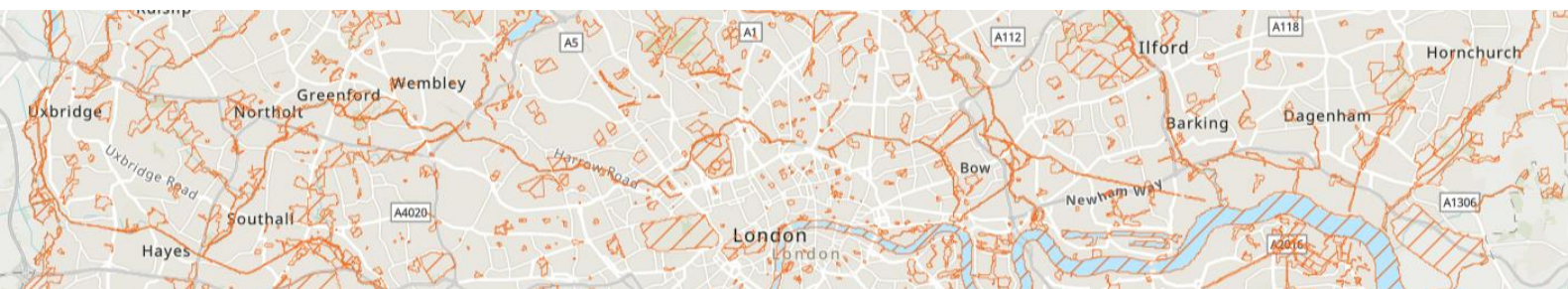
This is a sub-set of sites from GiGL's [Open Space database](#). GiGL manages a database of information about London's more than 12 thousand open spaces, their features and facilities. The data are updated when London boroughs, site managers, members of the public or other stakeholders inform GiGL of changes or during verification checks carried out by GiGL using other data sources. Data are updated on an on-going basis as information becomes available.

The sites selected for inclusion in the Publicly Accessible Open Space map on Discover-London are those open spaces that have public access, based on information collated by GiGL, and are likely to have local interest in the form of Friends Of group or neighbourhood group. This excludes sites where there is no access to the public and certain primary uses. It includes primary use categories: amenity green space, common, community garden, Country Park, formal garden, park, public woodland, recreation ground and village green, plus additional sites added on a case-by-case basis.

Copyright and terms of use: The open space database includes a collated data which have been compiled from a range of sources. Data providers retain copyright on their data and GiGL have the copyright of the overall database. Some features are derived from Ordnance Survey data.

Wildlife Sites



Description and sources: Selected sites from GiGL's [Sites of Importance for Nature Conservation \(SINC\)](#) database. Click on any site to open a pop-up with more information, including a link to the full site description hosted on the GiGL website.

London's equivalent of Local wildlife sites, these sites are recognised for the important habitats they support. SINCs are designated by a panel of local ecological professionals. This is a non-statutory designation, although SINCs are still afforded a high level of protection within the planning system. Development that negatively impacts on a SINC will only be permitted in exceptional circumstances and where mitigation can be proven from the beginning. There are three tiers of sites: Metropolitan, Borough (Grade 1 and 2) and Local.

The sites selected for inclusion in the Publicly Accessible Wildlife Sites map on Discover-London are those SINCs that have public access, based on information provided by Local Planning Authorities. This excludes SINC sites where there is no access to the public, such as railway linesides.

Copyright and terms of use: The SINC dataset is a collated dataset which has been compiled from a range of sources. Data providers retain copyright on their data and GiGL have the copyright of the overall dataset. Some features are derived from Ordnance Survey data.

These divide England into 159 distinct natural areas. Each is defined by a unique combination of landscape, biodiversity, geodiversity, history, and cultural and economic activity. 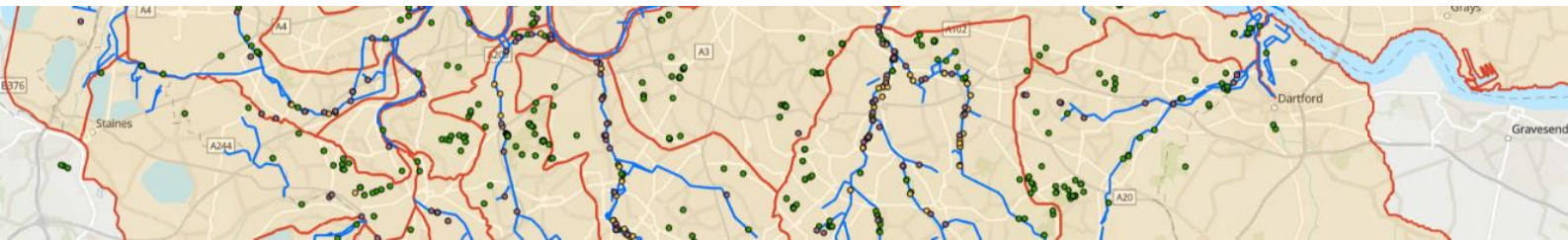

Environment Agency River Catchments

A layer showing all river catchment boundaries in London. Catchments are defined as an area of land from which all surface run-off flows through a series of streams, rivers and, possibly, lakes to a particular point in the water course such as a river confluence. This data also contains areas of land which drain directly to the coastal or estuarine waters, rather than through a river water body.

Click on any catchment on the map to view its name.

Urban River survey

The [Urban River Survey](#) is a scientific assessment method and suite of tools that supports the work of river managers in urban environments. The survey, which is a development of the Environment Agency's River Habitat Survey, records information on the physical structure of 500m stretches of urban rivers and their margins.

Click on the points on the map to view survey results recorded at that location. Click on the link in 'More Information' to view the full details for this location, hosted on GiGL's website.

Indices calculated from survey data are used to assess the relative physical quality of individual surveyed stretches within the range achievable in an urban environment. The Urban River Survey does not evaluate chemical or biological quality. It does assess the quality of the physical structure of riparian and aquatic vegetation.

The Urban River Survey is the product of 10 years of research by Angela Gurnell in collaboration with Angela Boitsidis, Lucy Shuker, Geraldene Wharton, and May Lee, conducted at Queen Mary University of London, King's College London, and the University of Birmingham, and funded by the Natural Environment Research Council, Natural England, and the European Commission.

Thames Water for Wildlife Results

Results of the [Clean Water for Wildlife Survey](#) collected as part of [The Thames Water For Wildlife project](#), which ran from 2015 to 2017. The project helped thousands of people to connect with their local freshwater environment through community involvement—increasing people's knowledge, enjoyment and appreciation of the freshwater habitats around them.

The community survey aimed to assess water quality across all types of freshwater habitats. Volunteers used quick kits to measure the levels of two widespread nutrient pollutants, nitrate and phosphate. The aim was to discover amazing 'clean' unpolluted water where wildlife can thrive and to raise awareness of the true extent of nutrient pollution affecting freshwater life today.

The [LNHS](#) is a local natural history society within the UK concerned with recording the wildlife of London. The LNHS helps local recorders to find, identify and record a wide variety of species across the LNHS

recording area, which covers a 20-mile (32km) radius from St. Paul's Cathedral in central London.

The boundaries on the map represent the inner and overall recording areas in London. Click on either area on the map to view its name and display a link where more information can be found.

The society aims include to foster the appreciation and study of London's wildlife and natural environment and assisting in the conservation of wildlife in the London area by helping to record London's wildlife. Society activities include running both indoor and

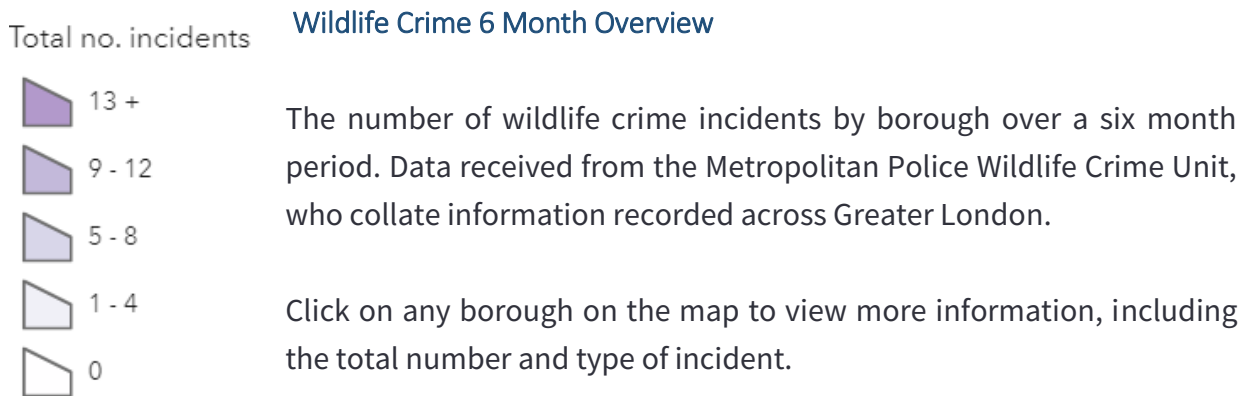


Wildlife Crime Intelligence by month
